PREAMBLE

This Memorandum of Understanding (MoU) is executed on this 07 day of Nov, 2025, between:

PRAKASH SHIKSHAN FOUNDATION'S LOKNETE RAJARAMBAPU PATIL AYURVEDIC MEDICAL COLLEGE AND HOSPITAL, POST GRADUATE INSTITUTE AND RESEARCH CENTRE, ISLAMPUR (hereinafter referred to as "LRP Ayurvedic College"), and

BIOCYTE INSTITUTE OF RESEARCH AND DEVELOPMENT (BIRD), Sangli (hereinafter referred to as "BiRD"),

with a mutual desire to collaborate for academic, research, innovation, and entrepreneurship development in the field of Ayurveda, pharmaceutical sciences, and biomedical research.

OBJECTIVES

- 1. To promote joint research and development activities in Ayurveda, pharmacology, toxicology, phytochemistry, and life sciences.
- 2. To foster entrepreneurship and start-up culture by providing guidance, incubation, and technical support for product innovation and commercialization.
- 3. To encourage joint research publications in indexed journals (Scopus / Web of Science / UGC CARE).
- 4. To undertake collaborative work leading to patent filing and technology transfer.
- 5. To provide hands-on training and exposure to animal house facilities to students under expert supervision.
- 6. To organize demonstrations and training sessions on calibration techniques, instrumentation handling, and analytical procedures.
- 7. To promote adherence to Good Laboratory Practices (GLP) and standard operating protocols for quality research.

SCOPE OF COLLABORATION

- Conducting joint research projects of mutual interest and social relevance.
- Organizing seminars, guest lectures, conferences, and workshops on research methodology, innovation, and Good Laboratory Practices.
- Facilitating training in modern laboratory techniques, calibration, and instrument maintenance.
- Sharing scientific expertise, data, and resources wherever appropriate.
- Promoting start-up and incubation initiatives related to herbal, herbomineral Ayurvedic formulations, analytical products, or biotechnology applications.
- Supporting joint publications and patents through collaborative authorship and institutional acknowledgment.



RESPONSIBILITIES OF THE PARTIES

LRP Ayurvedic College shall:

- Identify students and faculties for research collaboration and training.
- Provide subject expertise in Ayurvedic principles, pharmacognosy, and clinical aspects.
- Encourage staff and students to participate in research, publication, and innovation activities.
- Facilitate communication and coordination with regulatory bodies, if required.

Biocyte Institute of Research and Development (BiRD) shall:

- Provide access to laboratories, instruments, and animal house facilities for approved academic work.
- Conduct hands-on training in GLP, instrument calibration, microbiological and analytical techniques.
- Offer mentorship for research publication, patent drafting, and entrepreneurship initiatives.
- Support joint research proposals and facilitate technology transfer for innovative ideas.

LIABILITY AND CONFIDENTIALITY

- 1. Neither party shall be liable for any personal loss/damages arising during the execution of this MOU.
- 2. Both parties shall maintain confidentiality of proprietary or unpublished information shared under this MoU.

DURATION AND RENEWAL

This MOU shall remain valid for a period of five (05) years from the date of signing and may be extended upon mutual consent.

TERMINATION

Either party may terminate this MOU by giving one month's written notice. The termination shall not affect ongoing collaborative projects until their completion.
