This is an agreement between **Appasaheb Birnale College of Pharmacy, Sangli, Tal: Miraj Dist: Sangli** here in after called "ABCP" and **Biocyte Institute of Research And Development, near bypass road Kalanagar, Sangli, Dist. Sangli** here in after called "BiRD"

PURPOSE

This Memorandum of Understanding (MoU) establishes a cooperative relationship between **Biocyte Institute of Research And Development, Sangli, (BiRD Lab)** and **Appasaheb Birnale College of Pharmacy, Sangli (ABCP)**. 1. BACKGROUND

Appasaheb Birnale College of Pharmacy (Diploma) is affiliated to Board of Technical Examination started in 1985 and Degree course in Pharmacy was introduced in 1991 and is permanently affiliated to Shivaji University, Kolhapur. It has been awarded the status of 2F and 12 B by the University Grants Commission New Delhi. The Post graduate courses in Pharmacy were introduced from 2002 onwards and offer courses in Pharm Chem., Pharmacology, Pharmaceutics, and Quality Assurance all affiliated to Shivaji University, Kolhapur.

The College is an approved Ph. D Centre of Shivaji University, Kolhapur for pursuing Doctoral studies in Pharmacy.

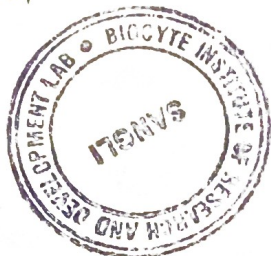
